



### Corona restrictions are changing in our favour

Slowly but steadily we are easing the Corona restrictions here in Denmark. This is what you need to know:

If you take part in a World or European championship, you are equal to a professional athlete (even if you don't earn a living by your sport). Professional athletes equals business travelers.

Have your club, federation or class organisation issue a statement that you are representing your country at the J/80 Worlds as a team and make sure that all of your names are in the document. Bring this document with you.

You will be quick tested in the airport when you fly in and you will be required to test again after 4 days. I will post more details on how and where later.

Here are the rules:

1. Currently most of the EU is in the orange category with the exemption shown below. However, our government is expecting to announce further ease on the requirements on June 26<sup>th</sup>.
2. If isolation is a requirement, you are - as a professional athlete - allowed to come out of isolation every day in order to take part in your sport, then go back into isolation until you after 4 days have your 2nd negative test - i.e. no socializing and beer on the pier after sailing in the beginning, but by sailors dinner day you should be fine.
3. For those of you who is required to have a worthy purpose: Representing your country in a World Championship is considered a worthy purpose.

As you can see from below travelling with vaccination or having had the covid-19 have the least restrictions.
